**Reservations require a payment of \$125.00 per campsite per night or \$75.00 per campsite per night for active duty and retired military personnel. Proof of service must be included with your reservation form to claim the military discount. Acceptable forms of proof include a copy of a Military ID card, Veteran ID card, driver's license with a veterans designation, VA issued identification card, DD214, or a membership card to a veterans group (such as VFW, American Legion, AMVETS, etc). Please redact any sensitive information (such as a Social Security Number) that appears on any document that you send. Reservations sent from a .mil account do not require further documentation.**

**Once your reservation has been booked we will send you a link to Pay.gov so you can complete payment. You will have 10 days from the receipt of the link to complete payment or your reservation will be cancelled. Payment must be completed prior to your camping date. Do not send payment information via email with this application.**

## Terms and Conditions of Use for the Rob Hill Campground

**Your reservation begins at 12:00 p.m. the day of check-in and ends at 11:00 a.m. the day of check-out.** Camping is permitted at designated Campsite(s) only. You may use the designated portions of the Campground solely for overnight camping and associated recreational enjoyment of the Campground and for no other purpose whatsoever. All charges are non-refundable. You may not assign your Campsite(s) to others outside of your group. You may not bring hazardous materials to the Campground other than reasonable and appropriate amounts of fuel for camping stoves and lanterns. You shall maintain the Campground in good condition; shall in no way alter the Campground; and shall dispose of your garbage in the provided receptacles, as marked; and surrender your Campsite(s) in a neat and clean condition. This Campsite Assignment may be revoked if any of the terms herein are violated or if the Presidio Trust believes that there exists a danger to life or property (e.g., in the event of significant rain or high winds). The Presidio Trust assumes no liability for any damage to or destruction of the Campground, the assigned Campsites, or your personal property. The Presidio Trust assumes no liability for personal injuries or deaths sustained in connection with or as a result of use of the Campground.

**Express Prohibitions.** You must comply with all applicable laws and restrictions. In addition, you are reminded that you are expressly prohibited from using weapons or controlled substances (other than prescription drugs) in the Campground or at the Presidio of San Francisco. Alcohol is NOT permitted. Smoking in the Campground is prohibited. Gambling in any form, or the operation of gambling devices, is prohibited. Pets are NOT permitted, except those specifically trained to assist the disabled. The use or possession of fireworks or explosives is prohibited. Fires are allowed in the BBQ and fire pit only. You must bring in your own wood, collecting downed or dead wood is prohibited. Feeding of animals is prohibited for both reasons of human safety and health of the wildlife. No amplified music or generators are allowed. No RVs/pop-ups or trailers are allowed at Rob Hill.

**Quiet Hours.** Quiet hours are designated as 10 p.m. to 6 a.m.

**No Temporary Residence.** Your Campsite Assignment is only a temporary grant of use of the Campground, which is revocable by the Trust at any time. You accept this assignment for purposes of overnight camping and associated recreational activities only. The Campground is not offered by the Trust for any residential purposes whatsoever, and you accept use of the Campground with the express understanding that you will not claim the Campground or any portion thereof as a residence or use the Campground or any portion thereof for residential purposes either temporary or permanent.

**Parking.** Parking on Central Magazine Road is by Permit only. Only active loading and unloading of vehicles in the designated loading zone is permitted. Four (4) Parking Permits per campsite are included with your Permit. All permitted vehicles must be parked in the parking area that is located just outside the service road adjacent to the access gate, with a Parking Permit displayed on the vehicle. Checkout time is 11:00 a.m. from both the Campsite and parking area. All vehicles must be removed by that time. No RVs or trailers are allowed at Rob Hill. Vehicles improperly parked are subject to ticketing and towing by the United States Park Police.

**Assumption of Risk.** You agree (on behalf of yourself and those in your group) to assume the risk of any harm or damage that may befall you or any member of your group while in the Campground. You further understand and agree that the Presidio Trust (and its directors, officers, and employees) is not responsible for loss, destruction, or damage to property; nor is the Presidio Trust (or its directors, officers, and employees) responsible for the death or injury of any persons at the Campground. This assumption of risk, shall not apply to exempt anyone from responsibility for his own fraud, or willful injury to the person or property of another, or willful or negligent violation of law. This assumption of risk shall survive termination and/or expiration of your Campsite Assignment.
