COVID-19 “Shelter in Place” Order and Emergency Declaration
Message from Jean S. Fraser, Chief Executive Officer, Presidio Trust

To All Residents, Tenants, and Visitors to the Presidio:

In response to COVID-19, the Presidio Trust is following and will continue to follow guidance from the City and County of San Francisco, including the San Francisco Department of Public Health's [recommendations](#), and the measures we are taking in the Presidio align us with that guidance. Our highest priority is the health and well-being of park visitors, residents, tenants, and employees.

Because parks and the outdoors are very helpful to maintaining our mental and physical health, particularly in stressful times, the Presidio Trust is keeping the park open, though most park-operated facilities, such as the Presidio Visitor Center and the Presidio Officer's Club are closed. The City's directive permits people to be outside so long as they are not in groups and follow social distancing requirements.

City and County of San Francisco “Shelter in Place” Order

On March 16, 2020, the City and County of San Francisco Department of Public Health Officer issued "[Shelter in Place](#)" Order No. C19-07. The City's Order directs all individuals living in the County to shelter at their place of residence, except that they may leave to provide or receive certain essential services, or engage in certain essential activities and work for essential business and government services. The City's Order became effective at 12:01 a.m. on March 16, 2020 and is in effect until 11:59 p.m. on April 7, 2020. The City's Order may be extended, rescinded, superseded, or amended by the City, but only in writing.

Presidio Emergency Declaration

In light of the existence of confirmed cases of coronavirus COVID-19 in the Bay Area counties, guidelines and recommendations from public health authorities, and the City's Order, I have declared that the COVID-19 outbreak is an emergency that threatens public health and safety in the Presidio. Accordingly, I have taken, and will continue to take, all actions appropriate under

the circumstances to maintain public health and safety in connection with the COVID-19 outbreak on lands administered by the Presidio Trust within the Presidio. I hereby order that:

All outdoor activities on lands administered by the Presidio Trust within the Presidio will be restricted to those activities permitted in the City's Order. (36 CFR § 1001.3; 36 CFR § 1001.5.) Individuals may (and are encouraged to) engage in outdoor activities in the Presidio such as, by way of example and without limitation, walking, hiking, or running. All persons must maintain at least six feet of social distancing from other individuals while outdoors.

The Presidio Emergency Declaration will continue to be in effect until 11:59 p.m. on April 7, 2020. The Presidio Emergency Declaration may be extended, rescinded, superseded, or amended.

The Presidio Trust has posted a copy of this message and the City's Order on the Presidio Trust's website (presidio.gov/coronavirus) and on the front door of the offices of the Presidio Trust at 103 Montgomery Street, San Francisco, CA 94129. In addition, the owner, manager, or operator of any facility that is likely to be impacted by this message and the City's Order is strongly encouraged to post a copy of the documents onsite.
